# THIRD AMENDMENT ON REGULATION OF THE MINISTER OF TRADE NUMBER 87/M-DAG/PER/10/2015 CONCERNING PROVISIONS FOR CERTAIN PRODUCT IMPORTATION

#### BY THE GRACE OF THE ALMIGHTY GOD

#### THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA.

- Considering: a. that to assist to increase business activity to small and medium industry, it is necessary to conduct amendment towards some provisions in the Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia Of 2015 Number 1553) as amended lastly with Regulation of the Minister of Trade Number 81 Of 2017 concerning Second Amendment on the Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia of 2017 Number 1506);
  - that based on consideration as intended in letter a, it is necessary to stipulate Regulation of the Minister of Trade concerning Third Amendment on Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation;



In view of: Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia Of 2015 Number 1553) as amended lastly with Regulation of the Minister of Trade Number 81 Of 2017 concerning Second Amendment on Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia Of 2017 Number 1506);

#### HAS DECIDED:

To stipulate: REGULATION OF THE MINISTER OF TRADE CONCERNING THIRD AMENDMENT ON REGULATION OF THE MINISTER OF TRADE NUMBER 87/M-DAG/PER/10/2015 CONCERNING PROVISIONS FOR CERTAIN PRODUCT IMPORTATION.

#### Article I

Some provisions in Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia of 2015 Number 1553) as amended lastly with Regulation of the Minister of Trade Number 81 of 2017 concerning Amendment on Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia of 2017 Number 1506) are amended as follows:

1. Provisions of Article 19 are amended so that Article 19 shall read as follows:

#### Article 19

Provisions in this Regulation of Minister are not in effect towards importation of:

a. Certain Products covering in Article 25 paragraph (1) and Article 26 paragraph (1) Law Number 10 of 1995 concerning Customs Affairs as amended with Law Number 17 of 2006;



- b. Certain Products of Ready-wear clothes in the form of delivery goods, passengers' and transportation means crew's private goods using airplane maximum 10 (ten) pieces;
- c. Certain Products of electronic in the form of delivery goods maximum 2 (two) units of each delivery as well as passengers' and transportation means crew's private goods having value of the most FOB U\$ 1,500.00 (one thousand five hundred American dollars) per person, using airplane;
- d. Certain Products other than as intended in letter b and letter c, in the form of delivery goods or passengers' and transportation means crew's private goods having value of the most FOB U\$ 1,500.00 (one thousand five hundred American dollars) per person, using airplane;
- e. Certain Products for the needs of upsteam activity of oil and natural gas, geothermal and mineral as well as other energy sectors;
- f. Certain Products imported by company that possessing API-P, used as inventory, raw materials, and/or assisting materials related to its industry;
- g. Certain Products imported by company that possessing API-U, used to fulfill small and medium industry raw material needs that does not conduct Certain Product importation itself, in the form of:
  - 1. Food and Beverages, not including hard candy (HS Post Number 17.04) and cigar (HS Post Number 24.02), with maximum amount 500 kg (five hundred kilograms) of each delivery;
  - 2. Traditional Medicine and Health Supplement with maximum amount 500 kg (five hundred kilograms) of each delivery; and
  - 3. Electronic, not including Cellular Devices (HS Post Number 85.17) and Microphone and its Stand (HS Post Number 85.18), with maximum quantity 10 (ten) pieces of each delivery.
- h. Certain Products of temporary import destination.
- 2. Provisions for Appendix of Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain Product Importation (Official Gazette of the Republic of Indonesia of 2015 Number 1553) as amended lastly with Regulation of the Minister of Trade Number 81 of 2017 concerning Second Amendment on Regulation of the Minister of Trade Number 87/M-DAG/PER/10/2015 concerning Provisions for Certain



Product Importation (Official Gazette of the Republic of Indonesia of 2017 Number 1506) are amended so that as attached in Appendix of this Regulation of Minister.

Article II

This Regulation of Minister comes into effect on its stipulation date.
