REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA

NUMBER 57/M-DAG/PER/8/2017

CONCERNING

STIPULATION OF RICE CEILING PRICES

BY THE GRACE OF THE ALMIGHTY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that to maintain stability and assurance of rice price, as well as the achievability of rice price on consumer, it is necessary to stipulate rice ceiling prices;
 - b. that based on consideration as intended in letter a, it is necessary to stipulate Regulation of the Minister of Trade concerning Stipulation of Rice Ceiling Prices;

- In view of :
1. Law Number 39 of 2008 concerning State Ministry (State Gazette of the Republic of Indonesia of 2008 Number 166, Supplementary State Gazette of the Republic of Indonesia Number 4916);
 2. Law Number 18 of 2012 concerning Food (State Gazette of the Republic of Indonesia of 2012 Number 227, Supplementary State Gazette of the Republic of Indonesia Number 5360);
 3. Law Number 7 of 2014 concerning Trade (State Gazette of the Republic of Indonesia of 2014 Number 45, Supplementary State Gazette of the Republic of Indonesia of 2014 Number 5512);



4. Governmental Regulation Number 17 of 2015 concerning Food Security and Nutrient (State Gazette of the Republic of Indonesia of 2015 Number 60);
5. Presidential Regulation Number 7 of 2015 concerning Organization of State Ministry (State Gazette of the Republic of Indonesia of 2015 Number 8);
6. Presidential Regulation Number 48 of 2015 concerning Trade Ministry (State Gazette of the Republic of Indonesia of 2015 Number 90);
7. Presidential Regulation Number 71 of 2015 concerning Stipulation and Storage of Basic Commodity and Important Goods (State Gazette of the Republic of Indonesia of 2015 Number 138);
8. Regulation of the Minister of Trade Number 08/M-DAG/PER/2/2016 concerning Organization and Administration of the Trade Ministry (State Gazette of the Republic of Indonesia of 2016 Number 202);

HAS DECIDED:

To stipulate : REGULATION OF THE MINISTER OF TRADE CONCERNING STIPULATION OF RICE CEILING PRICES.

Article 1

In this Regulation of Minister referred to:

1. Rice shall be grains either skinned, or not skinned, processed, or unprocessed originating from *Oriza Sativa* species.
2. Medium Rice shall be type of rice having whiten degree specification minimum 95%, water content maximum 14% and broken granule maximum 25%.
3. Premium Rice shall be type of rice having whiten degree specification minimum 95%, water content maximum 14% and broken granule maximum 15%.
4. Rice Ceiling Prices hereinafter abbreviated as HET shall be the highest sale price of packaging and/or bulk rice in traditional market, modern stores and other retail sale places.



5. Minister shall be the minister administering governmental affairs in the field of trade.

Article 2

- (1) Rice HET is stipulated based on sale territory.
- (2) Rice HET is stipulated by Minister based on coordinating meeting result between related instances and other functionaries.
- (3) Rice HET as intended in paragraph (1) consists of Medium Rice HET and Premium Rice HET.
- (4) Medium Rice HET and Premium Rice HET as intended in paragraph (3) are attached in Appendix which is inseparable part of this Regulation of Minister.

Article 3

Business Doer in conducting rice sale in retail to consumer shall be obliged to follow HET provisions as intended in Article 2.

Article 4

- (1) Business Doer in conducting rice sale in retail using package shall be obliged to attach information for type of rice and HET information on the package.
- (2) Information for type of rice as intended in paragraph (1) is in the form of type of Medium Rice or Premium Rice.

Article 5

HET as intended in Article 2 shall come in effect on 1 September 2017.

Article 6

HET as intended in Article 2 can be evaluated from time to time.

Article 7

- (1) Business Doer violating Provisions of Article 3 and Article 4 shall be imposed administrative sanction in the form of business license revocation by the issuing officer.



- (2) Sanction as intended in paragraph (1) is conducted after being given written warning maximum 2 (two) times by the issuing officer.

Article 8

Provisions of this Regulation of Minister shall be excepted towards Medium Rice and Premium Rice stipulated as Special Rice by the Minister of Agriculture.

Article 9

As this Regulation of Minister comes in effect, provisions concerning reference purchasing price at the farmer level and reference sale price at the consumer level for rice as regulated in Regulation of the Minister of Trade Number 27/M-DAG/PER/5/2017 concerning Reference Purchasing Price at the Farmer Level and Reference Sale Price at the Consumer Level (State Gazette of the Republic of Indonesia of 2017 Number 695), shall be revoked and shall be declared null and void.

Article 10

This Regulation of Minister shall come into effect as from its date of stipulation.

For public cognizance, ordering the promulgation of this Government Regulation in the Official Gazette of the Republic of Indonesia.
