AMENDMENT TO REGULATION OF MINISTER OF TRADE NUMBER 41/M-DAG/PER/9/2009 CONCERNING PROVISIONS ON EXPORT OF COFFEE

BY THE GRACE OF GOD ALMIGHTY THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

- a. whereas the improvement of competitiveness, creation of healthy competition in the coffee sector and take into account the decision of the Indonesia Membership Working Group and Contribution of the Government of the Republic of Indonesia in International Organizations, it is necessary to transfer the payment of the membership contribution of Indonesia in the International Coffee Organization (ICO);
- whereas the considerations as referred to in item a, it is necessary to amend several provisions in the Regulation of the Minister of Trade Number 41/M-DAG/PER/9/2009
 concerning Provisions on Export of Coffee;
- whereas in this respect, it is deemed in letter a and letter b, it is necessary to stipulate the Regulation of the Minister of Trade.

REGULATION OF MINISTER OF TRADE CONCERNING AMENDMENT TO REGULATION OF MINISTER OF TRADE NUMBER 41/M-DAG/PER/9/2009 CONCERNING PROVISIONS ON EXPORT OF COFFEE

Article I

Several provisions in the Regulation of the Minister of Trade Number 41/M-DAG/PER/9/2009 concerning Provisions on Export of Coffee are amended as follows:

1. Provision in Article 6 is amended, so as to henceforth read as follows:

Article 6

- (1) To obtain SPEK as referred to in Article 5 (1), EKS or ETK shall submit the written application to the Agency as referred to in Article 5 paragraph (4) by attaching the photocopy of acknowledgment as EKS or ETK.
- (2) The agency as referred to in paragraph (1) shall issue SPEK within not later than 3 (three) business days as of the receipt of complete and correct application.
- (3) SPEK shall be effective for 30 (thirty) days as of the issue date and may be extended only 1 (one) time.
- (4) SPEK of which the effectiveness term exceeding the end of the coffee year as referred to in Article 4 paragraph (4), cannot be used as requirement for the export of coffee, and cannot be extended.
- (5) SPEK as referred to in Article 5 paragraph (1) shall be issued in 5 (five) folds consisting of:
 - a. Original sheet for local Customs and Excise Service Office;
 - b. First copy for domestic foreign exchange Bank;
 - c. Second copy for the Agency issuing SPEK;
 - d. Third copy for the Directorate General of Foreign Trade Affairs in this case the Directorate of Agricultural and Forestry Products Export, the Ministry of Trade; and
 - e. Fourth copy for the relevant EKS or ETK.
- (6) SPEK as referred to in paragraph (5) can be used for shipment from the port of export throughout Indonesia.
- 2. The provision of Article 7 is deleted.
- 3. The provision of Article 8 is amended so as to hence forth read as follows:

Article 8

- (1) The Agency as referred to in Article 5 paragraph (4) shall submit the monthly report on realization of issue of SPEK to the Director General through the Director for Agriculture and Forestry Products Export or through http://inatrade.kemendag.go.id within not later than the 10th (tenth) day of the next month.
- (2) The agency failing to fulfill the obligation to report the realization of issue of SPEK as referred to in paragraph (1), can be subjected to revocation of SPEK issuer.
- 4. The provision of Article 10 is amended so as to henceforth read as follows:

Article 10

- (1) ETK and EKS shall submit the quarterly written report on realization of export of coffee to the Director General through the Director for Agriculture and Forestry Products Export or through http://inatrade.kemendag.go.id.
- (2) The report as referred to in paragraph (1) shall be submitted within not later than every 10th day of October, 10th day of January, 10th day of April, and 10th day of July.
- (3) The form of report on realization of coffee exports shall be as per Appendix V forming integral part hereof.
- 5. Appendix III is deleted.
