REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA NUMBER: 30/M-DAG/PER/8/2008

REGARDING

DELEGATION OF AUTHORITY OF SIGNATURE OF DETERMINATION AND REVOCATION OF SURVEYOR AS EXECUTIVE OF VERIFICATION OR TECHNICAL SEARCH TO CERTAIN MINING PRODUCT EXPORT

BY THE GRACE OF ALLAH THE ONE SUPREME GOD THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering : a. that in order to increase the service to the business world in export sector and the smooth implementation of export of certain mining product, it is necessary to delegate the authority of signing of determination and revocation of surveyors as the executive of verification and technical search to certain mining product export;
 - b. that in this respect, it is necessary to stipulate the Regulation of the Minister of Trade;

HAS DECIDED:

To Stipulate : REGULATION OF MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA REGARDING DELEGATION OF AUTHORITY OF SIGNATURE OF DETERMINATION AND REVOCATION OF SURVEYOR AS EXECUTIVE OF VERIFICATION OR TECHNICAL SEARCH TO CERTAIN MINING PRODUCT EXPORT.

Article 1

In this Regulation of the Minister, by:

- Delegation of authority shall mean the transfer of part of authority of an official having authority to the other official to sign the letter of determination and revocation of surveyor as the executive of verification and technical search to certain mining product export, for and on behalf of the official as the authority holder.
- Surveyor shall mean the survey company obtaining authority from and stipulated by the Minister of Trade to carry out the verification and technical search to the certain mining product export.

Article 2

The authority of the Minister of Trade to sign a Decree on stipulation and revocation of Surveyor as the executive of

verification and technical search of the certain mining product export herein shall cover:

- a. determination of Surveyor as the executive of the verification or technical search to certain mining product export;
- addition and change of the operational areas of each Surveyor in carrying out the verification or technical search to certain mining product export; or
- revocation of determination of Surveyor as the executive of verification or technical search to certain mining product export.

Article 3

The Minister of Trade shall delegate the authority as referred to in Article 2 to the Director General of Foreign Trade.

Article 4

The implementation of delegation of authority as referred to in Article 3 shall be made by taking into account:

- a. good governance principles and good administration rule; and
- b. Provisions of legislation.

Article 5

This Regulation of the Minister shall become effective as of the stipulation date.

For public cognizance, it is instructed to promulgate this Regulation of Minister by inserting the same in the State Gazette of the Republic of Indonesia.
