# THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering : a. that for implementation of the provisions of Article 19 of Law No. 2 of 1981 regarding Legal Metrology, it is necessary to specify the size, shape, validity period of Calibration signs and Re-calibration of Meter Devices, Weighting Instrument and Equipment thereof (measurement Devices) of 2009;
  - that based on the considerations referred to in letter a, is necessary to stipulate Regulation of the Minister of Trade;

# : REGULATION OF MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA REGARDING CALIBRATION SIGN OF 2009

## Article 1

The Calibration signs of 2009 shall consist of Valid Signs, Invalidated Sign, Security Mark, Regional Sign and Employee Signs Entitled to be used in the calibration or re-calibration activities.

#### Article 2

- (1) Valid Signs as referred to in Article 1 shall be affixed and/or put on UTTP or on the Written Certificate, after being validated upon the calibration or re-calibration.
- (2) Invalidated Signs as referred to in Article 1 shall be affixed and/or put on UTTP failing to meet the requirements upon the calibration or re-calibration.
- (3) Security Sign as referred to in Article 1 shall be affixed and/or put on certain parts of UTTP already validated upon the calibration or re-calibration to prevent the exchange and/or changes.
- (4) Regional Signs and Eligible Employees Signs as referred to in Article 1 shall be affixed on UTTP upon the calibration to allow the identification of the domicile and employees conducting calibration.

#### Article 3

- Invalidated Signs as referred to in Article 2 paragraph (1) shall be in form of irregular pentagon, in which there is Arabic Numeral 09, consisting of 3 (three) sizes each at distance from the angle point and the side in front of the angle: 6 mm, 4 mm, and 2 mm.
- (2) The Valid Signs as referred to in Article 2 (1) shall be affixed



and/or placed as of January 1, 2009 until December 31, 2009.

- (3) The Validity Term as referred to in paragraph (1) shall be as of the affixing and/or placement date until:
  - a. The glass-made meter devices are broken, cracked or damaged.
  - b. November 30, 2019 for 1 (one) -phase and 3 (three)-phase kWh Meters.
  - c. November 30, 2015 for Floating and Fixed Meter Tank.
  - d. November 30, 2014 for Low Pressure Gas Meters.
  - e. November 30, 2014 for Household Water Meter.
  - November 30, 2011 for Meter Provers and Meter Vessel specifically used to test the Meter Provers.
  - g. November 30, 2010 for UTTP other than those in items a, b, c, d, e, and f.

#### Article 4

- (1) Invalidated Signs as referred to in Article paragraph of equilateral triangle in which there are 13 (thirteen) parallel lines perpendicular to one of the sides, consisting of 3 (three) sizes, each with diameter of: 6 mm, 4 mm and 2 mm.
- (2) The Invalidated Signs as referred to in paragraph (1) shall have a validity term as of its affixation and/or placement until the UTTP is declared to be used again and provided with valid sign.

## Article 5

Security Signs as referred to in Article 2 paragraph (3) shall be in form of a circle in which there is a picture of a 8 (eight) leaf-lotus, consisting of 4 (four) sizes, each with a diameter: 8 mm, 5 mm, 4 mm and 2 mm.

# Article 6

Regional Sign as referred to in Article 2 paragraph (4) shall be in form of ellipse in which there is Arabic Numerals indicating the code

of Legal Metrology organization units in Indonesia, consisting of 2 (two) sizes, each with a long axis of 8 mm and short axis of 6 mm, and long axis of 4 mm and short axis of 3 mm.

# Article 7

The Eligible Employee signs as referred to in Article 2 paragraph (4) shall be in form of circular in which there is Greek letters indicating the Eligible Employee's initial, consisting of 3 (three) sizes, each with a diameter: 8 mm, 5 mm and 4 mm.

#### Article 8

Security Signs as referred to in Article 5, Regional Signs as referred to in Article 6, and Eligible Employee Sign as referred to in Article 7 have validity period starting from their affixation and/or placement on UTTP until the issue of revocation thereof.

#### Article 9

The Model of Valid Signs as referred to in Article 3 paragraph (1), Invalidated Signs as referred to in Article 4 paragraph (1), Security Signs as referred to in Article 5, the Regional Signs as region referred to in Article 6 and Eligible Employee Signs as referred to in Article 7 shall be as set forth in Attachment hereto.

#### Article 10

This Regulation of Minister shall become effective as of the stipulation date.

For public cognizance, it is instructed to promulgate this Regulation of Minister by inserting the same in the State Gazette of the Republic of Indonesia.
