MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA NUMBER 62 OF 2018

CONCERNING DETERMINATION OF SPECIAL PRICE OF RACE CHICKEN MEAT

UPON GRACE OF THE ONE ALMIGHTY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering : a. That in order to guarantee the availability, stability and certainty of the race chicken meat price approaching, during, and after the Idul Fitri 2018 holidays, it is necessary to determine the special price of race chicken meat;
 - b. That based on the consideration, as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade concerning the Determination of the Special Price of Race Chicken Meat;
- In view of : 1. Law Number 39 of 2008 concerning State Ministry (State Gazette of the Republic of 2008 Number 166, Supplement to the State Gazette of the Republic of Indonesia Number 4916);

- Law Number 18 of 2012 concerning Food (State Gazette of the Republic of Indonesia of 2012 Number 227, Supplement to the Sate Gazette of the Republic of Indonesia Number 5360);
- Law Number 7 of 2014 concerning Trade (State Gazette of the Republic of Indonesia of 2014 Number 45, Supplement to the State Gazette of the Republic of Indonesia Number 5512);
- Government Regulation Number 17 of 2015 concerning Food Security (State Gazette of the Republic of Indonesia of 2016 Number 60);
- Presidential Regulation Number 7 of 2015 concerning State Ministry Organization (State Gazette of the Republic of Indonesia of 2015 Number 8);
- Presidential Regulation Number 48 of 2015 concerning Ministry of Trade (State Gazette of the Republic of Indonesia of 2015 Number 90);
- Presidential Regulation Number 71 of 2015 concerning Determination and Storage of Basic Needs Goods and Important Goods (State Gazette of the Republic of Indonesia of 2015 Number 138);
- Regulation of the Minister of Trade Number 08/M-DAG/PER/2/2016 concerning Organization and Work Procedure of the Ministry of Trade (State Gazette of the Republic of Indonesia of 2016 Number 202);

HAS DECREED:

To determine : THE REGULATION OF THE MINISTER OF TRADE CONCERNING DETERMINATION OF THE SPECIAL PRICE OF RACE CHICKEN MEAT.

Article 1

The Minister determines the special price of race chicken meat approaching, during and after the Idul Fitri 2018 holidays.

Article 2

The supplier should sell race chicken meat to supermarkets and public markets based on the special price as meant in Article 1 with the following provisions:

- Maximum Rp.31,500/kg for the Special Region of Jakarta Capital City Province, West Java, and Banten.
- Maximum Rp.30,000/kg for East Java and Central Java Provinces; and
- c. Maximum Rp.32,000/kg for provinces other than as meant in letter a and letter b.

Article 3

Supermarkets and public markets should sell race chicken meat to consumers based on the special price as meant in Article 1 with the following provisions:

- Maximum Rp.33,000/kg for the Special Region of Jakarta Capital City Province, West Java, and Banten;
- Maximum Rp. 31.500/kg for East Java and Central Java Provinces; and
- c. Maximum Rp. 34,000/kg for province other than as meant in letter and letter b.

Article 4

The special prices of race chicken meat for suppliers as meant in Article 2, applies as of 21 May 2018 until 16 June 2018.

Article 5

The special prices of race chicken meat for supermarkets and public markets as meant in Article 3, applies as of 22 May 2018 until 16 June 2018.

Article 6

- (1) Business actors who violate the provisions in Article 2 and Article 3 are imposed the administrative sanction in form of revocation of the business license by the license issuance official.
- (2) The sanction, as meant in paragraph (1), is carried out after being provided maximum 2 (two) written warnings by the license issuance official.

Article 7

This Regulation of the Minister commences applicable as of the date of enactment and is retroactive as of 21 May 2018.

For public cognizance, it is instructed to promulgate this Regulation of Minister by inserting the same in the State Gazette of the Republic of Indonesia.
