**REGULATION OF MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA  
NUMBER 27/M-DAG/PER/9/2011  
CONCERNING  
DETERMINATION ON STANDARD PRICING FOR DUTIABLE EXPORT ITEMS**

**BY THE GRACE OF GOD THE ALMIGHTY  
MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,**

- Considering :
- a. whereas for order to implement Article 2 paragraph (3), Regulation of Minister of Trade Number 17/M-DAG/PER/5/2009 concerning Procedure of Determination on Standard Pricing for Dutiable Export Items which has been several times by virtue of Regulation of Minister of Trade Number 25/M-DAG/PER/9/2011, it is necessary to regulate the determination of Export Standard Pricing for the dutiable export items;
  - b. whereas determination on Standard Pricing for the Dutiable Export Items is made after taking into account written proposal and the meeting of coordination with the related technical agency;
  - c. whereas based on the consideration as referred to in letter a and letter b, it is necessary to stipulate Regulation of Minister of Trade;

3. Government Regulation Number 55 of 2008 concerning Imposition on Export Duty towards Export Items (State Gazette of the Republic of Indonesia of 2008 Number 116, Supplement to State Gazette of the Republic of Indonesia Number 4886);
4. Presidential Decree Number 260 of 1967 concerning Affirmation on Duty and Responsibility of Minister of Trade for Foreign Trade;
5. Regulation of President Number 47 of 2009 concerning Establishment and Organization of State Ministry;
6. Regulation of President Number 24 of 2010 concerning *Position, Task, and Function of State Ministry* and Organizational Structure, Task, and Function of Echelon I of State Ministry;
7. Presidential Decree Number 84/P of 2009 concerning Establishment and Appointment of Kabinet Indonesia Bersatu II;

12. Decree of Minister of Trade Number 01.2/M-DAG/KEP/1/2011 concerning Establishment of Team for Determination on Standard Pricing for Dutiable Export Items;

**DECIDED:**

To Stipulate : **REGULATION OF MINISTER OF TRADE CONCERNING DETERMINATION ON STANDARD PRICING FOR DUTIABLE EXPORT ITEMS.**

**Article 1**

Determination on Standard Pricing for Export (HPE) shall be made referring to average international rate or average price of FOB within the last one month before the stipulation.

**Article 2**

- (1) Export Duty Fee for the commodities of Palm Oil, Crude Palm Oil (CPO), and their downstream products referring to reference price based on the average price of CPO CIF Rotterdam, average price of CPO of Malaysia stock change and/or average price of CPO, Jakarta stock change, and for the commodities of Cacao Bean (Biji Kakao) referring to the price based on



average price of Biji Kakao CIF New York Board of Trade (NYBOT), New York, one month before the determination of HPE.

- (2) Reference price as referred to in paragraph (1) shall be as follows:
  - a. reference price of CPO in the amount of US\$ 1.072,63/MT;
  - b. reference price of Biji Kakao in the amount of US\$ 2.979,28/MT.
- (3) Based on reference price as referred to in paragraph (2), Export Duty tariff for Palm Oil, CPO and downstream products shall be as provided in column 8 Attachment I and for Biji Kakao shall be as provided in column 3 Attachment III of Regulation of Minister of Finance Number 67/PMK.011/2010 concerning Determination on Dutiable Export latters which has been by virtue of Regulation of Minister of Finance Number 128/PMK.011/2011.

### **Article 3**

HPE for the commodities of Palm Oil, CPO and their downstream products shall be stipulated as provided in Attachment I of Regulation of Minister.

### **Article 4**

List of mark RBD Palm Olein in packing with net weight of  $\leq 20$  kg shall be stipulated as provided in Attachment II of the Regulation of Minister.

### **Article 5**

HPE for the commodities of Wood, Rattan and Leather shall be stipulated as provided in Attachment III of the Regulation of Minister.





**Article 6**

HPE for the commodities of Biji Kakao shall be stipulated as provided in Attachment IV of Regulation of Minister.

**Article 7**

HPE as referred to in Articles 3, 5 and 6 shall be used as a basis of Determination on Export Price for the calculation of Export Duty by the Minister of Finance.

**Article 8**

HPE as referred to in Articles 3, 5 and 6 shall apply as of October 1, 2011 until October 31, 2011.

**Article 9**

In case HPE is expired based on the Regulation of Minister and the new HPE has not yet been stipulated, HPE as provided in Attachment I, III and IV of the Regulation shall be stated valid based on the calculation of Export Duty until the new HPE is stipulated.

**Article 10**

Upon the validity of the Regulation, Regulation of Minister of Trade Number 22/M-DAG/PER/8/2011 concerning Determination on Standard Pricing for Dutiable Export Items along with their appendices and Regulation of Minister of Trade Number 26/M-DAG/PER/9/2011 concerning Determination on Standard Pricing of Export for the dutiable Downstream Product of Crude Palm Oil along with the appendices thereof shall be revoked and stated invalid.



**Article 11**

Regulation of the Minister shall apply as of October 1, 2011.

For public cognizance, it is ordered to promulgate this Regulation of Minister by publish in the State Gazette of the Republic of Indonesia.
