## REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA

### NUMBER: 20/M-DAG/PER/5/2010

### REGARDING FARMER STANDARD PRICING (HPP) WHITE SUGAR PLANTATION

### BY THE GRACE OF THE GOD ALMIGHTY

### THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

•

- a. that to materialize food resilience to create selfsufficiency in sugar, and increase the competitiveness and income of sugar cane farmers and sugar industry, it is necessary to take efforts to maintain supply and stability of White Sugar Plantation price;
  - b. that to implement the provisions of Article 7 paragraph (5) of the Decree of the Minister of Industry and Trade No. 527/MPP/Kep/9/2004 regarding the Import of Sugar and by taking into account the letter of the Minister of Agriculture as the Chairman of the Indonesian Sugar Board Number 97/PP.2010/M/3 / 2010 dated March 3, 2010 regarding the proposal on Tariff of Farmers Sugar HPP in 2010, it is necessary to stipulate the Farmers' Standard Prices (HPP) of White Sugar Plantation;



- c. that the pricing as referred to in item b, should take into account the efforts to increase efficiency and productivity (sugar yield) in accordance with the sugar industry revitalization program in the home country;
- d. that based on the considerations as referred to in items
  a, b, and c, it is necessary to stipulate the Regulation
  of the Minister of Trade;

### HAS DECIDED:

# To Stipulate: REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA REGARDING FARMER STANDARD PRICING (HPP) WHITE SUGAR PLANTATION

### Article 1

In this Regulation by :

- White Sugar Plantation shall mean a sugar that can be consumed directly without further processing, which is included in Tariff Heading / HS. 1701.91.00.00 and 1701.99.90.00.
- 2. Farmers' Standard Price hereinafter abbreviated to HPP shall mean the standard price of White Sugar Plantation at the farmer level.
- 3. Minister shall mean the minister running the government's affairs in the trading field.

### Article 2

- (1) HPP of White Sugar Plantation shall be determined by the Minister.
- (2) The pricing as referred to in paragraph (1) shall be made by taking into account the suggestion of the Minister of Agriculture as the Chairman of the Indonesian Sugar Board.

### Article 3

HPP of White Sugar Plantation shall be Rp.6,350.- kg (six thousand three hundred and fifty dollars per kilogram)

### Article 4

Upon effectiveness hereof, the price of White Sugar Plantation at farmers level as stipulated in article 7 paragraph (2) item b, Article 7 paragraph (4) of Article 7 paragraph (5), and Article 13 paragraph of (1) The decision of the Minister of Industry and Trade No. 527/MPP/Kep/9/2004 regarding Import of Sugar as amended several times, most recently by the Regulation of the Minister of Trade Number 19/M-DAG/PER/5/2008, shall be revoked and declared null and void.



### Article 5

This Regulation of Minister shall become effective as of the stipulation date For public cognizance, it is instructed to promulgate this Regulation of Minister by inserting the same in the State Gazette of the Republic of Indonesia.
