- Considering :
- a. that the export policies have been well implemented, which is among others shown by the increase of the foreign exchange reserve;
  - b. that based on the results of the limited coordination meeting chaired by the Coordinating Ministry of Economic Sector on 17 July 2010 regarding the evaluation on the export arrangement implementation of commodities that should the Letter of Credit, such arrangement is considered no more needed;
  - c. that based on the considerations, as meant in letter a

2. Presidential Decree Number 260 of 1967 regarding Affirmation of the Duties and Responsibilities of the Minister of Trade in the Foreign Trade Sector;
3. Regulation of the President Number 47 of 2009 regarding Formation and Organization of the State Ministry;
4. Presidential Decree Number 84/P of 2009 regarding Formation of United Indonesia Cabinet I;
5. Regulation of the President Number 24 of 2010 regarding Status, Duties and Functions of the State Ministry and the Organization Structure, Duties and Functions of Echelon I of the State Ministry;
6. Regulation of the Minister of Trade Number 01/M-DAG/PER/3/2005 regarding Organization and Work Method of the Department of Trade as has been amended with the Regulation of the Minister of Trade Number 24/M-DAG/PER/6/2009.
