THIRD AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 46/M-DAG/PER/8/2013 CONCERNING PROVISIONS FOR IMPORT AND EXPORT OF ANIMALS AND ANIMAL PRODUCTS

BY THE GRACE OF ALLAH THE ONE SUPREME GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

- a. that in order to further improve the business certainty, support the development and availability of animals and animal products, as well as to improve the effectiveness of control on animal and animal product import, it is necessary to make several amendments on the provisions of the Regulation of the Minister of Trade Number 46/M-DAG/PER/8/2013 concerning Provisions for Import and Export of Animals and Animal Products, as has been amended several times and latest with the Regulation of the Minister of Trade Number 17/M-DAG/PER/3/2014;
- b. that based on the consideration, as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade concerning Third Amendment of the Regulation of the Minister

of Trade Number 46/M-DAG/PER/8/2013 concerning Provisions for Import and Export of Animals and Animal Products.

HAS DECIDED:

To Stipulate : THE REGULATION OF THE MINISTER OF TRADE CONCERNING

THIRD AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 46/M-DAG/PER/8/2013 CONCERNING PROVISIONS ON IMPORT AND EXPORT OF ANIMALS AND ANIMAL PRODUCTS.

Article I

Several provisions in Regulation of the Minister of Trade Number 46/M-DAG/PER/8/2013 as amended several times, the latest by Regulation of the Minister of Trade Number 17/M-DAG/PER/3/2014 is amended as follows:

1. The provisions of Article 1 are amended and now read as follows:

Article 1

- Animals are creatures which life cycle is entirely or partly on land, water and/or air, either those that are raised or those in their habitat.
- 2. Animal germ, hereinafter referred to as Germ, is the animal that has superior characteristic and inherits as well as complies with certain requirements to be cultivated.
- 3. Animal seed, hereinafter referred to as Seed, is the animal reproduction substance, which may be in form of cement, sperm, oval, egg sprout and embryo.
- 4. Broiler ruminant livestock cattle, hereinafter referred to as Calf, is the adult broiler ruminant livestock, which is cultivated during a certain period only to be fattened until reaching the maximum weight at the optimum age to be slaughtered.
- Animal female parent, hereinafter referred to as Female Parent, is the non seed female animal, which has a normal and healthy reproduction organ used for breeding.
- 6. Animal products are all products originating from animals that are still fresh and/or have been processed for needed

- for consumption, pharmakoseutica, agriculture, and/or other use to fulfill the need or benefit of human beings.
- 7. Zoonosis is the disease that can be transmitted from animal to human beings or reversely.
- 8. Export is the activity of taking out goods from the Customs Area.
- Import is the activity of entering goods into the Customs Area.
- 10. Animal and Animal Product Registered Importer hereinafter referred to as IT-Animal and Animal Product, is the company that imports Animals and Animal Products for the need of business activities by trading or handing over to another party.
- 11. Label is the information on the Animal Product in form of picture, writing, combination of both or other forms that contains information on the product and business actor as well as other information in accordance with the applicable provisions of the legislative regulations, attached to the product, put inside, affixed, or is part of the packing.
- 12. Food Tara Logo is the marking showing that the food packing is safe for the food.
- 13. Recycle Code is the marking showing that the food packing can be recycled.
- Packing is the material used to contain and or wrap the Animal Product, either directly in contact or not.
- 15. Import Approval is the approval to import Animals and/or Animal Products.
- 16. Export Approval is the approval to export Animals and/or Animal Products.
- 17. Recommendation is the statement issued by the authorized official of the related agency/technical unit, and is the requirement to issue the import approval and export approval.

- 18. Verification or technical tracing is the technical examination activity on import products that is carried out by the surveyor.
- 19. Surveyor is the survey company that obtains the authorization to carry out the verification and technical tracing on import products.
- 20. State Owned Enterprise, hereinafter refereed to as BUMN, is the business entity, which capital is on the overall or partially owned by the State through direct participation, originating from the separated State assets.
- 21. Minister is the minister who organizes the administration affairs in the trade sector.
- Director General is the Director General of Foreign Trade,
 Ministry of Trade.
- 23. The Trade Service Unit, hereinafter abbreviated UPP, is the unit that organizes the licensing service in the trade sector.
- 24. The UPP coordinator and executive is the Official appointed by the Secretary General of the Ministry of Trade to coordinate and carry out the implementation of the licensing service to the UPP.
- 2. 1 (one) article is inserted between Article 3 and Article 4, namely Article 3A, which reads as follows:

Article 3A

- (1) The cow species contained in Appendix I, as meant in Article 2 paragraph (2). Consists of Female Parent cows, Calf and cows ready for slaughter.
- (2) The import of Calf cows and cows ready for slaughter, as meant in paragraph (1), is proportionally determined by the Minister according to the need and based on the results of technical coordination with the Ministry of Agriculture.

 1 (one) article is inserted between Article 12 and Article 13, namely Article 12A, which reads as follows:

Article 12A

The request for the Import Approval of Female Parent Cows is exempted from the provision as meant in Article 12.

- Article 14 is deleted.
- 5. 5 (five) articles are inserted between Article 21 and Article 22, namely Article 21A, Article 21B, Article 21C, Article 21D, and Article 21E, which read as follows:

Article 21A

- (1) The verification or technical tracing is required to first be carried out in the Country of origin on each import of Animals and Animal Products.
- (2) The implementation of verification or technical tracing, as meant in paragraph (1), is carried out by the Surveyor determined by the Minister.

Article 21B

The Surveyor is required to be accompanied by the competent selector appointed by the Minister of Agriculture for each implementation of the verification or technical tracing on the import of Female Parent. Cows.

Article 21C

In order to be determined as implementer of the verification or technical tracing, as meant in Article 21A paragraph (2), the Surveyor should comply with the following requirements:

- a. in possession of the Survey Service Business License (SIUJS);
- b. experienced as Surveyor for minimum 5 (five) years;

- has branches or representatives and/or affiliations abroad;
 and
- d. in possession of good track records in the sector of import verification or technical tracing activity management.

Article 21D

- (1) The verification or technical tracing by the Surveyor, as meant in Article 21A paragraph (1), covers minimum the research and inspection of the data or information on:
 - a. identity (name and address) of importer and exporter;
 - b. amount/volume or weight;
 - c. type, specification, Tariff Post/HS of 10 (ten) digits and the description;
 - d. information on place or Country/port of loading, and port of destination;
 - e. country of goods origin; and
 - f. report of the inspection result on Female Parent Cows
 from the competent selector.
- (2) The result of verification or technical tracing carried out by the Surveyor, as meant in paragraph (1), is issued in form of the Surveyor Report (LS) to be used as the customs complimentary document at the customs settlement in the import sector.
- (3) The Surveyor collets the service reward from the IT-Animal and Animal Product and the company for the implementation of the verification and technical tracing on the import of Animals and Animal Products, which amount is determined by taking account of the benefit principle.

Article 21E

The verification or technical tracing activity on import of Animals and Animal Products by the Surveyor does not diminish the

authority of the Directorate General of Customs, Ministry of Finances, to carry out the customs inspection.

6. 1 (one) article is inserted between Article 25 and Article 26, namely Article 25A, which reads as follows:

Article 25A

The Surveyor is required to submit the:

- a. recapitulation on the result of verification and technical tracing for import of Animals and Animal Products by the IT-Animal and Animal Product and the company monthly to the Director General not later than the 15th (fifteenth) day of the following month;
- b. surveyor Report (LS) that has been issued through http://inatrade.kemendag.go.id.
- 7. 1 (one) article is inserted between Article 29 and Article 30, namely Article 29A, which reads as follows:

Article 29A

- (1) The violation by the Surveyor toward the provision of reporting requirement, as meant in Article 25A, is imposed the administrative sanction in form of withdrawal of the determination as Surveyor.
- (2) The withdrawal of determination as Surveyor, as meant in paragraph (1), is determined by the Minister.
- 8. Appendix I of the Regulation of the Minister of Trade Number 46/M-DAG/PER/8/2013, as has been amended several times and latest with the Regulation of the Minister of Trade Number 17/M-DAG/PER/3/2014, is amended and becomes as contained in Appendix, which is an inseparable part of this Regulation of the Minister.

Article II

This Regulation of the Minister commences applicable on 1 January 2015, except the provisions on verification and technical tracing, which commences applicable on 1 April 2015.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
