REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA NUMBER 96 OF 2018 CONCERNING REFERENCE PRICE OF BUYING AT THE FARMER'S LEVEL AND REFERENCE PRICE OF SELLING AT THE CONSUMER'S LEVEL

UPON GRACE OF THE ONE ALMIGHTY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering : a. that in order to guarantee the availability, stability and certainty of the corn, soybean, sugar, cooking oil, red onion, cow meat, purebred chicken meat, and purebred chicken eggs prices, it is necessary to re-regulate the provisions concerning the reference price of buying at the farmer's level and reference price of selling at the consumer's level;
 - b. that based on the consideration, as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade concerning the Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level.

HAS DECREED:

To determine : THE REGULATION OF THE MINISTER OF TRADE CONCERNING THE PRICE REFERENCE OF BUYING AT THE FARMER'S LEVEL AND PRICE REFERENCE OF SELLING AT THE CONSUMER'S LEVEL.

Article 1

The meaning of the following in this Regulation of the Minister is:

- The Reference Price of Buying at the Farmer's Level is the price of buying at the farmer's level that is determined by the Minister by considering the reasonable cost structure, covering among others the raw material cost, labor, land rent, profit, and/or other production input costs.
- 2. The Reference Price of Selling at the Consumer's level is the selling price at the consumer's level that is determined by the Minister by considering the reasonable cost structure, covering among others the acquisition cost, transportation and distribution costs, other retribution/collection costs, profit, and/or other costs.
- 3. Business Actor is each Indonesian citizen individual or business entity in form of legal entity or non legal entity, which is established and domiciled within the jurisdiction of the Unitary State of the Republic of Indonesia, carrying out the business activities in the trade sector.
- 4. Distribution Business Actor is the Business Actor that domestic carries out the distribution activities of goods
- Minister is the minister who organizes the administration affairs in the trade sector.

Article 2

- (1) The determination of the Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level is carried out on the staple commodities consisting of corn, soybean, sugar, cooking oil, red onion, cow meat, purebred chicken meat and purebred chicken eggs.
- (2) The Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level, as meant in paragraph (1), are contained in the Appendix, which is an integral part of this Regulation of the Minister.

Article 3

- (1) In case the price at the farmer's level is below the Reference Price of Buying at the farmer's level, then the Minister may assign the State Owned Company to buy in accordance with the Reference Price of Buying at the Farmer's Level.
- (2) In case the price at the consumer's level is below the Reference Price of Selling at the consumer's level, then the Minister may assign the State Owned Company to sell in accordance with the Reference Price of Selling at the Consumer's Level.
- (3) The assignment, as meant in paragraph (1) and paragraph (2) is provided after the Minister has made the coordination with the minister who organizes the administration affairs in the agriculture sector and the minister who organizes the administration affairs in the coordination, synchronization and ministry affairs control in organizing the administration in the economic sector.
- (4) The assignment, as meant in paragraph (3) for the:
 - a. Meat and soybean commodities is provided to the Public Company (Perum) BULOG; and
 - Sugar, cooking oil, red onion, cow meat, purebred chicken meat, and purebred chicken eggs commodities is provided to the Public Company (Perum) BULOG and/or

other State Owned Companies.

Article 4

In the buying and selling of commodities, as meant in Article 3 paragraph (1) and paragraph (2), the Public Company (Perum) BULOG and/or other State Owned Companies may cooperate with the Regional State Owned Companies, cooperatives and/or the private sector.

Article 5

The Distribution Business Actor of staple goods should in the buying and selling of corn, soybean, sugar, cooking oil, red onion, cow meat, purebred chicken meat, and purebred chicken eggs refer to the Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level that are determined in this Regulation of the Minister.

Article 6

The Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level, as meant in Article 2 paragraph (2), apply for the period of 4 (four) months effective as of the date this Regulation of the Minister is applicable.

Article 7

In case the validity term of the Reference Price of Buying at the Farmer's Level and the Referenced Price of Selling at the Consumer's Level has expired and the new Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level have not been determined yet, then the Reference Price of Buying at the Farmer's Level and Reference Price and Reference Price of Selling at the Consumer's Level have not been determined yet, then the Reference Price of Buying at the Farmer's Level and Reference Price of Selling at the Consumer's Level and Reference Price of Selling at the Consumer's Level in this Regulation of the Minister are declared as still applicable.

Article 8

At the time this Regulation of the Minister commences applicable, the Regulation of the Minister of Trade Number 58 of 2018 concerning the Reference Price of Buying at the Farmer and the Reference Price of Selling at the Consumer (State Gazette of the Republic of Indonesia of 2018 Number 600) is revoked and declared as not applicable.

Article 9

This Regulation of the Minister commences applicable on 1 October 2018.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
