REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA NUMBER: 29/M-DAG/PER/6/2009

REGARDING

AMENDMENTS ON THE REGULATION OF THE MINISTER OF TRADE NUMBER 05/M-DAG/PER/4/2005 REGARDING THE REQUIREMENTS ON IMPORT OF MACHINERY, MACHINE EQUIPMENT, RAW MATERIALS AND OPTICAL DISCS

BY THE GRACE OF ALLAH THE ONE SUPREME GOD THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

•

S.

- a. that the Regulation of the Minister of Trade Number 05/M-DAG/PER/4/2005 regarding the requirements on Import of Machinery, Machine Equipment, Raw Materials, and Optical Disc only regulates the importation for the requirement of optical disc industry;
- b. that the Import of Machinery, Machine Equipment, Raw Materials, and Optical Disc is not only for the requirement of optical disc industry but also for the requirement of those other than optical disc industry;
- c. that in the context of supporting the smoothness of Machinery, Machine Equipment, Raw Materials, and Optical Disc importation for requirement of those other than optical disc industry, by still paying attention to the

purpose of Copyright protection policy, it needs to amend the Regulation of the Minister of Trade Number 05/M-DAG/PER/4/2005;

- that based on such considerations as referred to in letter a, letter b, and letter c it needs to stipulate a Regulation of the Minister of Trade.

: REGULATION OF THE MINISTER OF TRADE REGARDING AMENDMENTS ON REGULATION OF THE MINISTER OF TRADE NUMBER 05/M-DAG/PER/4/2005 REGARDING THE REQUIREMENTS ON IMPORT OF MACHINERY, MACHINE EQUIPMENT, RAW MATERIALS AND OPTICAL DISCS.

Article I

Some of provisions in the Regulation of the Minister of Trade Number 05/M-DAG/PER/4/2005 regarding the Requirements on Import of Machinery, Machine Equipment, Raw Materials and Optical discs are amended as follows:

 The provisions in Article 1 are amended, therefore Article 1 shall run as follows:

Article 1

In this Regulation of the Minister what's meant by:

 Machinery and Machine Equipment are any kinds of machine and equipment used in the production process of Blank Optical Disc and/or Loaded Optical Disc.

 Raw Materials are any forms of material usable in the production process of Blank Optical Disc and/or Loaded Optical Disc.

- 3. Optical Disc is any kinds of recording media having the form of disc loadable with or having the load of data and or information in the form of voice, music, film, or other data and/or information readable by scanning technology mechanism in optical way by using sources of beam with high intensity such as laser.
- Blank Optical Disc is Optical Discs in blank form which constitute the final results of a production process having no data and/or information in them.
- 5. Loaded Optical Disc is Optical Discs which constitute the final results of a production process with high technology having the load of data and/or information in the form of either voice, music, film or other data and/or information.
- Production Code is Source Identification Code (SID code) consisting of stamper code and mould code that must be affixed on Loaded Optical Discs.
- 7. Registered Importer of Optical Disc, hereinafter shall be referred to as IT Optical Disc, is a company or Industry in optical disc sector owning an Importer Identity Number (API) approved by the Director General to Import Machinery, Machine Equipment, Raw Materials, Blank Optical Discs and/or Loaded Optical Discs.
- Registered Importer of Non-optical Disc, hereinafter shall be referred to as IT Non-optical Disc, is a company or industry of other than optical

disc sector owning an Importer Identity Number (API) approved by the Director General to Import Machinery, Machine Equipment, Raw Materials, Blank Optical Discs and/or Loaded Optical Discs.

- Recommendation is a letter issued by the officials of instances / units authorized to deliver technical explanation and constituting no license or approval of import.
- 10. Director General is the Director General of Overseas Trade, the Ministry of Trade.
- 11. Minister is the Minister whose duties and responsibilities are in trade sector.
- 2. The provisions in Article 2 are amended, therefore Article 2 shall run as follows:

- Machinery, Machine Equipment, Raw Materials, Blank Optical Disc and Loaded Optical Disc regulated in this Regulation of the Minister as contained in Attachment I constitute an inseparable part of this Regulation of the Minister.
- (2) Such Machinery, Machine Equipment, Raw Materials, Blank Optical Disc and Loaded Optical Disc as referred to in paragraph (1) shall have to meet the technical requirements according to the provisions in statutory regulation.
- (3) Such Loaded Optical Disc as referred to in paragraph (1) must be affixed with a Production Code based on the requirements and custom applicable internationally.
- Between Article 2 and Article 3 it is inserted 1 (one) article, i.e. Article 2A so it shall run as follows:



Article 2A

Such Machinery, Machine Equipment, Raw Materials, Blank Optical Disc and Loaded Optical Disc as referred to in Article 2 paragraph (1) can only be imported by a Company or industry in optical disc sector having been appointed as an IT Optical Disc.

4. The provisions in Article 3 are amended, therefore Article 3 shall run as follows:

- Such appointment as IT Optical Disc as referred to in Article 2A shall be stipulated by the Director General.
- (2) To be capable of being appointed as an IT Optical Disc as referred to in paragraph (1), a company or industry in optical disc sector shall have to submit a written application to the Director General by enclosing the documents of:
 - A copy of Industrial Business License, Industrial Registration Certificate or other equal Business Licenses From Technical Ministries / Non-Ministerial Governmental Institutions handling the optical disc sector;
 - b. A copy of Importer Identity Number (API);
 - c. A copy of Company Registration Certificate (TDP);
 - d. A copy of Tax-Payer Number (NPWP);
 - A copy of Customs Affairs Identity Number (NIK);
 - f. Recommendation from the Director General of Metal, Machinery, Textile and Varied Industries of Department of Industry for the importation of Machinery and Machine

- g. Recommendation from the Director General of Agro and Chemical Industry of the Department of Industry for the importation of raw Materials and Blank Optical Disc; and
- Recommendation from the Director General of Intellectual Property Rights of Department of Law and Human Rights for the importation of Loaded Optical Disc.
- 5. Between Article 4 and Article 5 it is inserted 2 (two) articles, i.e. Articles 4A and 4B so they shall run as follows:

Article 4A

In the event that any companies or industries other than optical disc sector need such Machinery, Machine Equipment, Raw Materials, Blank Optical Discs and Loaded Optical Discs as referred to in Article 2 paragraph (1), those companies or industries may do the import upon having obtained a Registration Certificate as IT Non-Optical Disc.

Article 4B

- Such Registration certificate as IT non-optical disc as referred to in article 4A shall be issued by the Director General.
- (2) To obtain such Registration Certificate as IT Non-Optical Disc as referred to in paragraph (1), any companies or industries other than optical disc sector shall have to submit a written application to the Director General by enclosing the documents of:
 - a. A copy of Importer Identity Number (API);
 - b. A copy of Company Registration Certificate

- c. A copy of Tax-Payer Number (NPWP); and
- d. A copy of Customs Affairs Identity Number (NIK).
- 6. The provisions in Article 5 are amended, therefore Article 5 shall run as follows:

Article 5

Such appointment as an IT Optical Disc as referred to in Article 3 and such Registration Certificate as referred to in Article 4A shall apply for a period of 3 (three) years and is expendable.

7. The provisions in Article 6 are amended, therefore Article 6 shall run as follows:

- (1) Such IT Optical Disc as referred to in Article 2A which is going to import Machinery, Machine Equipment, Raw Materials, Blank Optical Discs and Loaded Optical Discs is obliged to obtain an import approval from the Director General in this matter Director of Import.
- (2) To obtain such import approval as referred to in section (1), an IT Optical Disc has to submit a written application to the Director General in this matter director of import by enclosing:
 - Recommendation from the Director General of Metal, Machinery, Textile and Varied Industries of Department of Industry for the importation of Machinery and Machine Equipment;
 - Recommendation from the Director General of Agro and Chemical Industry of Department of Industry for the importation of Raw



Materials and Blank Optical Disc; or

- Recommendation from the Director General of Intellectual Property Rights of Department of Law and Human Rights for the importation of Loaded Optical Disc.
- 8. The provisions in Article 7 are amended, therefore Article 7 shall run as follows:

- (1) An IT Optical Disc which has received such import approval as referred to in Article 6 is obliged to submit a written report of import realization and the realization of Machinery, Machine Equipment, Raw Materials, Blank Optical Discs and Loaded Optical Discs distribution to the Director General in this matter Director of Import once in every 3 (three) month period.
- (2) An IT Non-Optical Disc is obliged to submit a report of import realization once in every 3 (three) month period to the Director General in this matter Director of Import with a cc to:
 - a. Director General of Metal Industry, Machinery, Textile and Varied Industries in this matter the Director of Machinery Industry of the Department of Industry for Machinery and Machine Equipment importation;
 - b. Director General of Agro and Chemical Industry in this matter the Director of Downstream Chemical Industry of the Department of Industry for Raw Materials and Blank Optical Discs importation; and
 - c. Director General of Intellectual Property Rights in this matter the Director of Copyright, Industrial Design, Design of Integrated Circuit



Layout, and Trade Secrets of the Department of Law and Human Rights for Loaded Optical Discs importation.

- (3) Such report of import realization and distribution as referred to in paragraph (1), as well as such report of import realization as referred to in paragraph (2) must be submitted at the latest on the 15th of the next period's first month via <u>http://inatrade.depdag.co.id</u> in the form of report as contained in Attachment II and Attachment III which constitute an inseparable part of this Regulation of the Minister.
- 9. Between Article 9 and Article 10 it is inserted 1 (one) article, i.e. Article 9A so it shall run as follows:

Article 9A

- The provisions in this Regulation of the Minister shall not apply on the import of Blank Optical Discs and Loaded Optical Discs conducted by:
 - a. governmental instances and state institutions;
 - representatives of foreign countries along with their officers assigned in Indonesia;
 - c. international agencies along with their officers assigned in Indonesia;
 - d. individual as removal goods;
 - e. passengers and crew of transporting facilities, with the maximum number of 10 (ten) pieces; and
 - f. individual through a courier service, with the maximum number of 10 (ten) pieces.
- (2) On each of such imported Blank Optical Discs and loaded optical discs as referred to in paragraph (1) still apply the requirements of customs affairs administration.



- (3) On each of such imported Loaded Optical Discs as referred to in paragraph (1) must be affixed a Production Code.
- 10. Between Article 11 and Article 12 it is inserted 1 (one) article, i.e. Article 11A so it shall run as follows:

Article 11A

- The Registration Certificate as an IT Non-Optical Disc shall be revoked when the concerned company:
 - failed to perform its obligation to submit such report of import realization as referred to in Article 7 paragraph (2) and paragraph (3); and/or
 - amended, added, and/or replace any contents contained in the document of Registration Certificate as an IT Non-Optical Disc.
- (2) The revocation on such recognition as an IT Optical Disc as referred to in paragraph (1) shall be conducted by the Director General.
- Attachment I, Attachment II, Attachment III, and Attachment IV to the Regulation of the Minister of Trade Number 05/M-DAG/PER/4/2005 are amended, to become the Attachment I, Attachment II, and Attachment III to this Regulation of the Minister.

Article II

This Regulation of the Minister shall be in effect as of its stipulation date.

In order to let everyone be aware of, instructing the announcement of this Regulation of the Minister by posting it in the State Gazette of the Republic of Indonesia.
