AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 53/M-DAG/PER/8/2012 CONCERNING IMPLEMENTATION OF FRANCHISE

UPON GRACE OF THE ONLY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

- a. That in the framework of providing certainty and business order in the implementation of Franchise, it is necessary to amend several provisions in the Regulation of the Minister of Trade Number 53/M-DAG/PER/8/2012 concerning Implementation of Franchise;
- b. That based on the consideration, as meant in letter a, it is necessary to determine the Regulation of The Minister of Trade concerning the Amendment of the Regulation of the Minister of Trade Number 53/M-DAG/PER/8/2012 concerning the Implementation of Franchise.

HAS DECREED:

To enact

THE AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 53/M/DAG/PER/8/2012 CONCERNING IMPLEMENTATION OF FRANCHISE.

Article I

Several provisions of the Regulation of the Minister of Trade Number 53/M-DAG/PER/8/2012 concerning Implementation of Franchise are amended as follows:

 1 (one) article is inserted between Article 9 and Article 10, namely Article 9A, and reads as follows:

Article 9A

- (1) The candidate Franchise Provider who submits the request for STPW, as meant in Article 9, should submit the Master Franchise Agreement as contained in Appendix IV letter A of this Regulation of the Minister.
- (2) The STPW issuance official examines the Master Franchise Agreement within the period of 20 (twenty) working days.
- (3) In case the Master Franchise Agreement, as meant in paragraph (1), is considered as not opposing the provisions of legislative regulations, then the candidate Franchise Provider may continue the process of the STPW request by completing the documents that are the requirements in the in the STPW request, as contained in Appendix IV of this Regulation of the Minister.
- (4) In case the Master Franchise Agreement, as meant in paragraph (1), is considered as opposing the provisions of the legislative regulations, then the STPW request is rejected.

(2) Appendix IV of the Regulation of the Minister of Trade Number 53/M-DAG/PER/8/2012 concerning Implementation of Franchise is amended and becomes as contained in the Appendix of this Regulation of the Minister.

Article II

This Regulation of the Minister commences applicable on the date of enactment.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
