SECOND AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 16/M-DAG/PER/4/2013 CONCERNING IMPORT OF HORTICULTURE PRODUCTS

UPON GRACE OF THE ONE ALMIGHTY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering : a. that to more improve the effectiveness of the implementation and control on the policy for import of horticulture products, it is necessary to amend the Regulation of the Minister of Trade Number 16/M-DAG/PER/4/2013 concerning Provisions for Import of Horticulture Products, as has been amended with the Regulation of the Minister of Trade Number 47/M-DAG/PER/8/2013;

- b. that based on the consideration as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade concerning Second Amendment of the Regulation of the Minister of Trade Number 16/M-DAG/PER/4/2013 concerning Provisions for Import of Horticulture Products;

HAS DECREED:

To determine : THE REGULATION OF THE MINISTER OF TRADE CONCERNING SECOND AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 16/M-DAG/PER/4/2013 CONCERNING PROVISIONS FOR IMPORT OF HORTICULTURE PRODUCTS.

Article I

Several provisions in the Regulation of the Minister of Trade Number 16/M-DAG/PER/4/2013 concerning Provisions for Import of Horticulture Products, as has been amended with the Regulation of the Minister of Trade Number 47/M-DAG/PER/8/2013, are amended as follows:

 1 (one) article is inserted between Article 12 and Article 13, namely Article 12A, which reads as follows:

Article 12A

- The Import Approval, as meant in Article 12, may be distinguished as follows:
 - a. Import Approval for Fresh Horticulture Products;
 - b. Import Approval for Fresh Horticulture Products, especially Chili (fruit from genus Capsicum), with the Tariff Post/HS 0709.60.10.00, and Red Onion for consumption with Tariff Post/HS 0703.10.29.00; and
 - c. Import Approval for Processed Horticulture Products.
- (2) The IT-Horticulture Product may obtain more than 1 (one)Import Approval, as meant in paragraph (1).
- 2. The provision of Article 13 is amended and reads as follows:

Article 13

- (1) In order to obtain the Import Approval, as meant in Article 11, the IT-Horticulture Product should electronically submit the request to the Minister, in this case the UPP Coordinator and Executive, by attaching the following:
 - a. RIPH; and
 - b. Determination as IT-Horticulture Product.
- (2) The UPP Coordinator and Executive, on behalf of the Minister, issues the:
 - a. Import Approval within not later than 2 (two) working days as of the request is received completely and correctly; or
 - Rejection to issue the Import Approval within not later than 2 (two) working days as of the date the request is received incompletely and/or incorrectly.
- (3) The Import Approval, as meant in paragraph (2) letter a, is submitted to the IT-Horticulture Product and copies are submitted to the related agencies.
- (4) The issuance of the Import Approval, as meant in paragraph (2), should take account of the ability and worthiness of the storage place and transportation equipment in accordance with the characteristics of the Horticulture Product possessed by the IT-Horticulture Product.

3. The provisions of Article 13A paragraph (1) and paragraph (2) are amended so that Article 13A reads as follows:

Article 13 A

- (1) The time to submit the request for the Import Approval for Fresh Horticulture Products, as contained in Appendix I of this Regulation of the Minister, is determined as follows:
 - a. For the first Semester, namely the period of January to June, may only be submitted in December; and
 - b. For the second Semester, namely the period of July to December, may only be submitted in June.
- (2) The request for Import Approval for:
 - a. Fresh Horticulture Products, especially Chili (fruit from *genus Capsicum*), with the Tariff Post/HS 0709.60.10.00 and fresh Red Onion for consumption, with the Tariff Post/HS 0703.10.29.00; and
 - b. Processed Horticulture Products,

as contained in Appendix I of this Regulation of the Minister, may be submitted at any time.

- (3) The Import Approval, as meant in paragraph (1), is issued every beginning of the semester.
- 4. The provision of Article 14A is amended and reads as follows:

Article 14A

(1) The IT-Horticulture Product that has obtained the Import

Approval, as meant in Article 13 paragraph (2) letter a, should realize the import of Horticulture Products of minimum 80% (eighty percent) of the Import Approval for each product as contained in the Import Approval.

- (2) The provision on the obligation of the IT-Horticulture Product to realize the import of Horticulture Products of minimum 80% (eighty percent) of the Import Approval, as meant in paragraph (1), does not apply for the Import Approval for Processed Horticulture Products.
- 5. The provision of Article 25A is amended and reads as follows:

Article 25A

- (1) The determination as IT-Horticulture Product is frozen in case the company is unable to implement the obligation of realizing the Import Approval as meant in Article 14A.
- (2) The freezing of the determination as IT-Horticulture Product, as meant in paragraph (1), is carried out during 2 (two) Semester periods.
- 6. The provision of Article 27 is amended and reads as follows:

Article 27

The freezing of determination as IT-Horticulture Product, as meant in Article 25A, and the withdrawal of recognition as IP-Horticulture Product and the determination of IT-Horticulture Product, as meant in Article 26, are determined by the UPP Coordinator and Executive for and on behalf of the Minister.

7. Appendix I of the Regulation of the Minister of Trade Number 16/M-DAG/PER/4/2013 concerning Provisions for Import of Horticulture Products, as has been amended with the Regulation of the Minister of Trade Number 47/M-DAG/PER/8/2013, is amended and becomes as contained in the Appendix, which is an inseparable part of this Regulation of the Minister.

Article II

This Regulation of the Minister commences applicable on the date of enactment, except the provision of Article 25A, which commences applicable on 1 July 2015.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
