REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA NUMBER 53/M-DAG/PER/7/2015 CONCERNING PROVISIONS FOR IMPORT OF TEXTILE AND BATIK AND BATIK MOTIVE TEXTILE PRODUCTS

UPON GRACE OF THE ONE ALMIGHTY GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering: a. that batik has been recognized by the United Nations Educational Scientific and Cultural Organization (UNESCO) as the cultural heritage of Indonesia, so that its existence and originality need to be maintained;
 - b. that in the framework of maintaining the existence and originality of the Indonesian batik, protecting the intellectual property right and protecting the consumer, it is necessary to control the import of textile and batik and batik motive textile products;

- c. that based on the considerations, as meant in letter a and letter b, it is necessary to determine the Regulation of the Minister of Trade concerning the provisions for Import of Textile and Batik and Batik Motive textile Products.

HAS DECREED:

To determine: THE REGULATION OF THE MINISTER OF TRADE CONCERNING PROVISIONS FOR IMPORT OF TEXTILE AND BATIK AND BATIK MOTIVE TEXTILE PRODUCTS.

Article 1

The meaning of the following in this Regulation of the Minister is:

 Textile and Batik Textile Products, hereinafter abbreviated Batik TPT, is batik sheet cloth that contains color combination of minimum 2 (two) colors and is produced through the batik process and is used as the raw material or supporting material, and products using the batik sheet cloth.

- 2. Textile and Batik Motive Textile Products, hereinafter abbreviated Batik Motive TPT, is batik motive sheet cloth that contains color combination of minimum 2 (two) colors and is produced by machine (printing), which is used as raw material or supporting material, and products using batik motive sheet cloth.
- 3. Import is the activity of taking in goods into the customs area.
- 4. Textile and Batik and Batik Motive Textile Products Registered Importer, hereinafter referred to as Batik and Batik Motive IT-IPT, is the company in possession of the Importer Identity Number (API) that is approved to import Batik TPT and Batik Motive TPT for the need of business activities.
- Import Approval is the license to import Batik TPT and Batik Motive TPT.
- 6. Recommendation is the letter issued by the authorized official from the related ministry/technical institution that technically provides the explanation and is not an import license or approval.
- Verification or technical tracing is the investigation and checking on imported goods carried out by the Surveyor.
- 8. Surveyor is the survey company that has obtained the authorization to carry out the verification or technical tracing on imported goods.

- 9. Minister is the minister who organizes the administrative affairs in the trade sector.
- Director General is the Director General of Foreign Trade, Ministry of Trade.
- Director is the Director of Import, Directorate General of Foreign Trade, Ministry of Trade.

Batik TPT and Batik Motive TPT, which import is limited, are as contained in Appendix I, which is an inseparable part of this Regulation of the Minister.

Article 3

- (1) The import of Batik TPT and Batik Motive TPT, as meant in Article 2, may only be carried out by the company that has obtained the determination as Batik and Batik Motive IT-TPT from the Minister.
- (2) The Minister delegates the authority to issue the determination as Batik and Batik Motive IT-TPT, as meant in paragraph (1) to the Director General.

- (1) In order to obtain the determination as Batik and Batik Motive IT-TPT, as meant in Article 3, the company should electronically submit the request to the Director General by attaching the following:
 - a. Industrial Business License/Industrial Registration Identity, Trade Business License or other similar types of business licensed from the authorized agency;

- b. Importer identity Number (API);
- c. Taxpayer Registration Number (NPWP); and
- d. Customs Identity Number (NIK).
- (2) With regard to the request, as meant in paragraph (1), the Director General issues the determination of the Batik and Batik Motive IT-TPT within not later than 5 (five) working days effective as of the date the request is received completely an correctly.
- (3) In case the request, as meant in paragraph (1), is incomplete and incorrect, then the Director General submits the notification on the rejection of request within not later than 5 (five) working days as of the date the request is received.
- (4) The Director General delegates the authority to notify the rejection of request for determination as Batik and Batik Motive IT-TPT, as meant in paragraph (3) to the Director.

The determination as Batik and Batik Motive IT-TPT, as meant in Article 4 paragraph (2), applies for 2 (two) years effective as of the date of issuance.

- (1) The Bartik and Batik Motive IT-TPT should report each amendment related to the documents, as meant in Article 4 paragraph (1) letter a to letter d, and submits the request for the amendment of determination of Batik and Batik Motive IT-TPT.
- (2) In order to obtain the amendment of determination as Batik and Batik Motive IT-TPT, as meant in paragraph (1), the batik and Batik Motive

IT-TPT should electronically submit the request to the Director General by attaching the following:

- a. The amended document, as meant in paragraph (1); and
- b. The original determination as Batik and Batik Motive IT-TPT.
- (3) With regard to the request, as meant in paragraph (2), the Director General issues the amendment of determination as Batik and Batik Motive IT-TPT within not later than 5 (five) working days effective as of the date the request is received completely and correctly.

Article 7

- (1) The Batik and Batik Motive IT-TPT, as meant in Article 4 that is intended to import Batik TPT and Batik Motive TPT should obtain the import approval from the Minister.
- (2) The Minister delegates the authority to issue the Import Approval, as meant in paragraph (1) to the Director General.

- (1) In order to obtain the Import Approval, as meant in Article 7, the Batik and Batik Motive IT-TPT should electronically submit the request to the Director General by attaching the following:
 - a. Determination as Batik and Batik Motive IT-TPT;
 - b. Recommendation from the ministry that organizes the administration affairs in the industrial sector; and
 - c. Recommendation from the ministry that organizes the administration affairs in the cooperative and small and medium scale enterprise sector.

- (2) The recommendation, as meant in paragraph (1) letter b and letter c, should minimum contain information on the Tariff Post/HS, type, Batik TPT and Batik Motive TPT volume, import port of destination and the validity term.
- (3) With regard to the request, as meant in paragraph (1), the Director General issues the Import Approval within not later than 5 (five) working days effective as of the date the request is received completely and correctly.
- (4) In case the request, as meant in paragraph (1) is incomplete and incorrect, then the Director General submits the notification on the rejection of request within not later 5 (five) working days as of the date the request is received.
- (5) The Director General delegates the authority to notify the rejection of request for the Import Approval, as meant in paragraph (3) to the Director.

The Import Approval, as meant in Article 8 paragraph (3), applies for maximum 1 (one) year effective as of the date of issuance.

Article 10

(1) The Batik and Batik Motive IT-TPT may submit the request the amendment of the Import Approval in case there are amendments on the Tariff Post/HS, type, Batik TPT and Batik Motive TPT volume and/or import port of destination.

- (2) In order to obtain the amendment of the Import Approval, as meant in paragraph (1), the Batik and Batik Motive IT-TPT should electronically submit the request to the Director General by attaching the following:
 - a. Determination as Batik and Batik Motive IT-TPT;
 - b. Import Approval;
 - c. Recommendation from the ministry that organizes the administration affairs in the industrial sector; and
 - d. Recommendation from the ministry that organizes the administration affairs in the cooperative and small and medium scale enterprise sector.
- (3) With regard to the request, as meant in paragraph (2), the Director General issues the amendment of the Import Approval within not later than 5 (five) working days effective as of the date the request is received completely and correctly.

- (1) The submission of request to obtain the:
 - a. Determination as Batik and Batik Motive IT-TPT, as meant in Article4;
 - b. Amendment of the determination as Batik and Batik Motive IT-TPT, as meant in Article 6;
 - c. Import Approval, as meant in Article 8; and
 - d. Amendment of the Import Approval, as meant in Article 10,

can only be served with the electronic system through the INATRADE portal.

(2) In case of force majeure, which causes the non functioning of the electronic system through the INATRADE portal, then the submission of request, as meant in paragraph (1), is manually delivered.

Article 12

- (1) The Batik TPT and Batik Motive TPT that are imported by the batik and Batik Motive IT-TPT should be completed with information on the goods or packing in the Indonesian Language.
- (2) The information, as meant in paragraph (1), contains minimum the information or explanation on the goods, name of business actor, and address of the business actor, as contained in Appendix II, which is an inseparable part of this Regulation of the Minister.
- (3) The information, as meant in paragraph (2), is affixed in such a way so that it is not easily detached from the goods and/or packing and should be easily seen and read.
- (4) In addition to affixing the information in the Indonesian Language, the business actor may affix the information in other languages.

Article 13

Each import of Batik TPT and Batik Motive TPT may only be carried out through the following ports of destination:

- a. Seaport: Belawan in Medan, Tanjung Perak in Surabaya, and Soekarno Hatta in Makassar; and/or
- b. Airport: Soekarno Hatta in Tangerang.

- (1) The import verification or technical tracing should first be carried at the port of loading on each implementation of Batik TPT and Batik Motive TPT import.
- (2) The verification or technical tracing, as meant in paragraph (1), is carried out by the Surveyor determined by the Minister.

Article 15

In order to be determined as implementer of the verification or technical tracing on the import of Batik TPT and Batik Motive TPT, as meant in Article 14, the Surveyor should comply with the following requirements:

- a. In possession of the Survey Service Business License (SIUJS);
- b. Experienced as Surveyor in the import sector of minimum 5 (five) years;
- c. Has branches or representatives and/or affiliates abroad and has the network to support the effectiveness of the verification or technical tracing service; and
- d. In possession of good track records in the management of the import verification or technical tracing activity.

- (1) The verification or technical tracing, as meant in Article 14, covers minimum the data or information concerning:
 - a. Name and address of exporter;
 - b. Name and address of importer;
 - c. Type and amount of goods;
 - d. Tariff Post/HS and description of goods;

- e. Information on the goods/packing in the Indonesian Language;
- f. Product Certificate Number on the Use of the Indonesian National Standard Mark (SPPT SNI) for Batik TPT and Batik Motive TPT, which SNI is compulsory applied;
- g. Goods Registration Number;
- h. Country and port of loading;
- i. Time of shipment; and
- j. Port of destination.
- (2) The result of verification or technical tracing, as meant in paragraph (1), is entered into the form of Surveyor Report (LS) in order to be used as the customs supplementary document for the customs settlement in the import sector.
- (3) With regard to the implementation of the verification or technical tracing on the import of Batik TPT and Batik Motive TPT, the Surveyor charges the service reward from the importer, which amount is determined by taking account of the benefit principle.

The activity of verification or technical tracing on the import of Batik TPT and Batik Motive TPT, which is carried out by the Surveyor, does not diminish the authority of the Directorate General of Customs, Ministry of Finances, to perform the customs inspection.

- (1) The batik and Batik Motive IT-TPT should:
 - a. Submit the written report on the implementation of the Batik TPT and Batik Motive TPT import, either that is realized or not realized, through <u>http://inatrade.kemendag.go.id;</u> and
 - b. Attach the photocopy of the Import Realization Control Card that has been initialed and sealed by the Customs officer.
- (2) The report, as meant in paragraph (1) letter a, is submitted every 3 (three) months within not later than the 15th (fifteenth) day of the first month of the following quarter to the Director with copies to the ministry that organizes the administration affairs in the industrial sector and ministry that organizes the administration affairs in the cooperative and small and medium scale enterprise sector.

Article 19

The Surveyor should submit:

- a. The recapitulation on the result of import verification or technical tracing of Batik TPT and Batik Motive TPT monthly to the Director within not later than the 15th (fifteenth) day of the following month; and
- b. The Surveyor Report (LS) that has been issued through <u>http://inatrade.kemendag.go.id</u>.

Article 20

The determination as Batik and Batik Motive IT-TPT is withdrawn in case the company:

- a. Does not carry out the obligation of reporting each amendment of document, as meant in Article 6 paragraph (1);
- b. Does not carry out the obligation of affixing information in the Indonesian Language on the goods and/or packing, as meant in Article 12 paragraph (1);
- c. Does not carry out the obligation of submitting the report as meant in Article 18 paragraph (1);
- d. Submits incorrect data and/or information in the request for determination as Batik and Batik Motive IT-TPT and/or Import Approval;
- e. Is proven as amending the information contained in the determination as Batik and Batik Motive IT-TPT and/or Import Approval;
- f. Conducts violation in the customs sector based on information from the Directorate General of Customs, Ministry of Finances; and/or
- g. Is declared guilty based on the court verdict, which has permanent legal power, for the criminal act related to the misuse of determination as Batik an Batik Motive IT-TPT and/or Import Approval.

The withdrawal of the determination as Batik and Batik Motive IT-TPT, as meant in Article 20, is determined by the Director General.

Article 22

The company that has been imposed the sanction of the withdrawal as Batik and Batik Motive IT-TPT, as meant in Article 20, may submit the request to be re-determined as Batik an Batik Motive IT-TPT after 2 (two) years as of the date of the withdrawal as Batik and Batik Motive IT-TPT.

The determination as Surveyor for the implementation of the import verification or technical tracing of Batik TPT and Batik Motive TPT, as meant in Article, is withdrawn in case the Surveyor:

- a. Conducts violation in the implementation of the import verification or technical tracing of Batik TPT and Batik Motive TPT activity activity; and/or
- b. Does not carry out the obligation as meant in Article 19 for 2 (two) times.

Article 24

The withdrawal of the determination as Surveyor, as meant in Article 23, is determined by the Minister.

Article 25

- (1) The Importer that imports Batik TPT and Batik Motive TPT not in accordance with the provisions in this Regulation of the Minister may be imposed other sanctions based on the provisions of the Legislative regulations.
- (2) The Batik TPT and Batik Motive TPT, which are imported not in accordance with the provisions in this Regulation of the Minister, should be re-exported in accordance with the provisions of the legislative regulations.
- (3) The costs for re-export, as meant In paragraph (2), are borne by the importer.

Article 26

The Surveyor that caries out the import verification or technical tracing of Batik TPT and Batik Motive TPT not in accordance with the provisions in this

Regulation of the Minister may be imposed other sanctions based on the provisions of the legislative regulations.

Article 27

The provisions on the import verification or technical tracing, as meant in Article 14 paragraph (1), do not apply for the Batik Textile and Batik Motive Textile that are imported by the Batik and Batik Motive IT-TPT that obtains Export Destination Import Facilities (KITE).

Article 28

- (1) The entering of Batik TPT and Batik Motive TPT for the need of residents in the Free Trade Zone and Free Port from outside the Customs Area is regulated in accordance with the provisions of the legislative regulations concerning Free Trade Zone and Free Port.
- (2) The Batik TPT and Batik Motive TPT originating from outside the Customs Area are prohibited to taken out from the Free Trade Zone and Free Port to other locations in the customs area.

- (1) The provisions in this Regulation of the Minister do not apply for Batik Textile and Batik Motive Textile that are imported to the Bonded Zone and Bonded Warehouse.
- (2) The provisions in this Regulation of the Minister applies for Batik Textile and Batik Motive Textile originating from import, as meant in paragraph (1), which are taken out to other locations in the customs area.

(3) The verification or technical tracing should be carried out by the Surveyor at the Bonded Warehouse on the Batik Textile and Batik Motive Textile originating from import, as meant in paragraph (2).

Article 30

- (1) The provisions of obligation to be determined as Batik and Batik Motive IT-TPT and the Import Approval do not apply for Batik Textile products and Batik Motive Textile products as result of processing at the Bonded Zone, which are taken into other locations inside the customs area.
- (2) The provisions of obligation to carry out the import verification or technical tracing apply on Batik Textile products and Batik Motive Textile products as result of processing in the Bonded Zone, which part or overall raw materials are Batik Textile and Batik Motive Textile originating from import, as contained in Appendix I of this Regulation of the Minister, and are entered into other locations in the customs area.
- (3) The provisions of obligation to carry out the import verification or technical tracing do not apply on Batik Textile products and Batik Motive Textile products as result of processing in the Bonded Zone, which overall raw materials originate from domestic production, which are entered into other locations in the customs area.

Article 31

The provisions in this Regulation of the Minister do not apply on import of Batik TPT and Batik Motive TPT that are:

a. Goods for the need of the government or other state institutions;

- B. Goods of foreign country representatives including their officials who are assigned in Indonesia;
- c. Goods for the need of international organizations including their officials who are assigned in Indonesia;
- d. Moved belongings;
- e. Goods for the need of exhibition with the value of maximum FOB US\$ 1,500.00;
- f. Export goods that are rejected by the overseas buyer and then re-imported in the amount equal to the amount at the time of export;
- g. Batik textile and Batik Motive textile in form of goods that are sent through and/or not through the courier service or personal belongings of passengers, crew members of transportation means, or border crossers with the value of maximum FOB US\$ 1,500.00 per person by using aircraft.
- h. Batik textile products and Batik Motive textile products in form of goods that are sent through and/or not through the courier service or personal belongings of passengers, crew members of transportation means, or border crossers with the value of maximum US\$ FOB Us\$ 1,000.00 per person by using aircraft.

Exclusion from the provisions of this Regulation of the Minister may only be carried out by the Minister after obtaining the considerations from the ministry that organizes the administration affairs in the industrial sector and from the ministry that organizes the administration affairs in the cooperative and small and medium scale enterprise sector.

- (1) The determination as Certain IT-Product that has been issued based on the Regulation of the Minister of Trade Number 83/M-DAG/PER/12/2012 concerning Import Provisions for Certain Products, as has been amended several times and latest with the Regulation of the Minister of Trade Number 73/M-DAG/PER/10/2014 that is used to import Batik Textile Products and Batik Motive Textile Products with the similar description of goods and Tariff Post/HS as contained in Appendix I of this Regulation of the Minister, is declared as still applicable until the settlement of customs clearance for the implementation of this Regulation of the Minister.
- (2) The Surveyor Report (LS) that has been issued based on the Regulation of the Minister of Trade Number 23/M-DAG/PER/6/2009 concerning Provisions for Import of Textile and Textile Products, as has been amended with the Regulation of the Minister of Trade Number 02/M-DAG/PER/1/2010, is declared as still applicable until the settlement of customs clearance for the implementation of import of Batik Textile and Batik Motive Textile by the IP-Textile.
- (3) The Surveyor Report (LS) that has been issued based on the Regulation of the Minister of Trade Number 83/M-DAG/PER/12/2012 concerning Provisions for Import of Certain Products, as has been amended several times and latest with Regulation of the Minister of trade Number 73/M-DAG/PER/10/2014, is declared still applicable until

the settlement of customs clearance for the implementation of import of Batik Textile products and Batik Motive Textile products.

Article 34

At the time this Regulation of the Minister commences applicable:

- a. The provisions and description of goods and Tariff Post/HS on Batik Textile and Batik Motive Textile that are regulated in the Regulation of the Minister of TRADE Number 23/M-DAG/PER/6/2009 concerning Provisions for Import of Textile and Textile Products, as has been amended with the Regulation of the Minister of Trade Number 02/M-DAG/PER/1/2010; and
- b. The provisions and description of goods and Tariff Post/HS Batik Textile products and Batik Motive Textile products, as regulated in the Regulation of the Minister of Trade Number 83/M-DAG/PER/12/2012 concerning Provisions fro Import of Certain Products, as has been amended several times and latest with the Regulation of the Minister of Trade Number 73/M-DAG/PER/10/2014,

are withdrawn and declared not applicable.

This Regulation of the Minister commences applicable 90 (ninety) days as of the date of enactment.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
