- Considering
- a. that in order to optimize the preparedness for implementation of policies in the sector of import of forestry products, it is necessary to amend the Regulation of the Minister of Trade Number 78/M-DAG/PER/10/2014 concerning Provisions for Import of Forestry Products;
 - b. that based on the consideration, as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade concerning the Amendment of the Regulation of the Minister of Trade Number 78/M-DAG/PER/10/2014 concerning Provisions for Import of Forestry Products.

HAS DECREED:

To enact: **THE REGULATION OF THE MINISTER OF TRADE CONCERNING AMENDMENT OF THE REGULATION OF THE MINISTER OF TRADE NUMBER 78/M-DAG`PER/10/2014 CONCERNING PROVISIONS FOR IMPORT OF FORESTRY PRODUCTS.**

Article I

The provision of Article 28 in the Regulation of the Minister of Trade Number 78/M-DAG/PER/10/2014 concerning Provisions for Import of Forestry Products is amended and reads as follows:

Article 28

This Regulation of the Minister commences applicable on 1 September 2015.

Article II

This Regulation of the Minister commences applicable on the date of its enactment.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
