THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

Considering

: a. that in the framework of providing clarity and certainty on the use of the Freight Value and Insurance Value amount, it is necessary to amend the Regulation of the Minister of Trade Number 07/M-DAG/PER/1/2014 concerning the Determination of the Freight Value and Insurance Value at the Filling In of the Commodity Export Notification Related to the Use of the Terms of Delivery Cost, Insurance and Freight for the Implementation of Export;

b. that based on the consideration as meant in letter a, it is necessary to determine the Regulation of the Minister of Trade on the Amendment of the Minister of Trade Number 07/M-DAG/PER/1/2014 concerning the Determination of the Freight Value and Insurance Value at the Filling In of the Commodity Export Notification Related to the Use of the Terms of Delivery Cost, Insurance and Freight for the Implementation of Export;

HAS DECREED:

To Enact: THE REGULATION OF THE MINISTER OF TRADE ON THE

AMENDMENT OF THE REGULATION OF THE MINISTER OF

TRADE NUMBER 07/M-DAG/PER/1/2014 CONCERNING THE

DETERMINATION OF THE FREIGHT VALUE AND INSURANCE

VALUE AT THE FILLING IN OF THE COMMODITY EXPORT

NOTIFICATION RELATED TO THE USE OF THE TERMS OF DELIVERY COST, INSURANCE AND FREIGHT FOR THE IMPLEMENTATION OF EXPORT.

Article 1

The provision of Article 3 in the Regulation of the Minister of Trade Number 07/M-DAG/PER/1/2014 concerning the Determination of the Freight Value and Insurance Value at the Filling In of the Commodity Export Notification Related to the Use of the Terms Of Delivery Cost, Insurance and Freight for the Implementation of Export is amended so that it reads as follows:

Article 3

- (1) The freight Value and Insurance Value, as meant in Article 2, are the basis for calculation of the Freight Value and Insurance Value at the Commodity Export Notification that uses the Terms of Delivery Free On Board (FOB) and Cost and Freight (CFR).
- (2) The Freight Value and Insurance Value, as meant in paragraph (1), are not the basis for calculation of the Export Standard Price on the export commodity that is imposed the export duty and export duty tariff.

Article II

This Regulation of the Minister commences effective on 21 March 2014.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
