**CONCERNING
SPECIFICATION OF FREIGHT RATE AND INSURANCE VALUE TO FILL NOTICE
ON EXPORT OF GOODS RELATING TO THE USE OF TERM OF DELIVERY
COST, INSURANCE AND FREIGHT FOR THE IMPLEMENTATION OF EXPORT**

BY THE GRACE OF ALLAH THE ONE SUPREME GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that to implement Article 2 paragraph (1) Regulation of Minister of Trade Number 01/M-DAG/PER/1/2014 concerning Procedure for the Stipulation of Freight rate and Insurance Value to fill Notice on Export of Goods relating to the use of Term of Delivery Cost, Insurance and Freight for the Implementation of Export, it is necessary to specify freight rate and insurance value to fill Notice on Export of Goods;
 - b. that based on the consideration as referred to in item a, it is necessary to stipulate Regulation of Minister of Trade concerning the Specification of Freight rate and Insurance Value to Fill Notice on Export of Goods relating to the Use of Term of Delivery Cost, Insurance and Freight for the

implementation of export;

Law Number 10 of 1995 concerning Customs (State Gazette of the Republic of Indonesia Number 75 of 1995, Supplement to the State Gazette of the Republic of Indonesia Number 3612) as already amended by virtue of Law Number 17 of 2006 (State Gazette of the Republic of Indonesia of 2006 Number 93, Supplement to the State Gazette of the Republic of Indonesia Number 4661);
3. Presidential Decree Number 260 of 1967 concerning Affirmation on Duties and Responsibilities of the Minister of Trade in the Foreign Trade Sector;
4. Presidential Decree Number 84/P of 2009 concerning Establishment of the United Indonesia Cabinet II as it has been amended by virtue of the Presidential Decree Number 59/P of 2011;
5. Presidential Regulation Number 47 of 2009 concerning the Establishment and Organization of State Ministry as already amended several times lastly by virtue of Presidential Regulation Number 55 of 2013;
6. Presidential Regulation Number 24 of 2010 concerning Position, Duty and Function of State Ministry and Organizational Structure, Duty and Function of Echelon I of State Ministry already amended several times lastly by virtue of Presidential Regulation Number 56 of 2013;
7. Regulation of Minister of Trade Number 31/M-DAG/PER/7/2010 concerning Organization and Working Procedure for the Ministry of Trade as already amended by virtue of Regulation of Minister of Trade Number 57/M-DAG/PER/8/2012;
8. Regulation of the Minister of Trade Number 13/M-DAG/PER/3/2012 concerning General Provisions in the

Sector of Export;

9. Regulation of the Minister of Trade Number 01/M-DAG/PER/1/2014 concerning Procedure for the Specification of Freight rate and Insurance Value to fill Notice on the Export of Goods relating to the Use of Notice on Export of Goods relating to the Use of Term of Delivery Cost, Insurance and Freight for the Implementation of Export;

HAS DECIDED:

To Stipulate : **SPECIFICATION OF FREIGHT RATE AND INSURANCE VALUE TO FILL NOTICE ON EXPORT OF GOODS RELATING TO THE USE OF TERM OF DELIVERY COST, INSURANCE AND FREIGHT FOR THE IMPLEMENTATION OF EKSPOR.**

Article 1

Specification of Freight rate and Insurance Value shall be made based on the written input and result of meeting for the coordination of Specification Team for Freight rate and Insurance Value.

Article 2

Freight rate and Insurance Value as referred to in Article 1 shall be stipulated as contained in the Appendix being an integral part thereof.

Article 3

Freight rate and Insurance Value as referred in Article 2 shall be served as calculation basis on the Freight rate and Insurance Value in the Notice on Export of Goods using the terms of delivery free on Board (FOB) and Cost and Freight (CFR).

Article 4

Freight rate and Insurance Value as referred to in Article 2 shall apply as of March 1, 2014 up to December 31, 2014.

Article 5

In the event that the validity period of Freight rate and Insurance Value as referred to in Article 3 have expired and the new ones are not yet specified, the Freight rate and Insurance Value as contained in Attachment to Regulation of Minister shall be stated valid until the new Freight rate and Insurance Value is stipulated.

Article 6

The Regulation of Minister applies as of the promulgation.

For public cognizance, it is ordered to promulgate the Regulation of Minister by publicizing the same in the State Gazette of the Republic of Indonesia.
