# TYPES OF EXPORT AND IMPORT LICENSING, STANDARD OPERATING PROCEDURE AND SERVICE LEVEL ARRANGEMENT WITH THE ELECTRONIC SYSTEM THROUGH INATRADE IN THE FRAMEWORK OF THE INDONESIA NATIONAL SINGLE WINDOW

### BY THE GRACE OF ALLAH THE ONE SUPREME GOD THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

#### Considering

- : a. that in order to implement the provisions of Article 2 paragraph (3) and Article 8 paragraph (3) of the Regulation of the Minister of Trade Number 28/M-DAG/PER/6/2009 concerning Provisions of Export and Import Licensing Service with the Electronic System through INATRADE in the Framework of the Indonesia National Single Window;
  - b. that in order to improve the effective, efficient and transparent licensing service to the business world, it is necessary to add the types of licensing that may and may only be served with the electronic system through INATRADE in the framework of the Indonesia National Single Window;

c. that based on the considerations as meant in letter a and letter b, it is necessary to enact the Regulation of the Minister of Trade concerning the Types of Export and Import Licensing, Standard Operating Procedure and Service Level Arrangement with the Electronic System Through INATRADE in the Framework of the Indonesia National Single Window.

#### **HAS DECIDED:**

To stipulate

: **REGULATION** OF THE **MINISTER** OF TRADE CONCERNING **TYPES** OF **EXPORT** AND **IMPORT** LICENSING. STANDARD OPERATING PROCEDURE AND SERVICE LEVEL ARRANGEMENT WITH THE ELECTRONIC SYSTEM THROUGH INATRADE IN THE FRAMEWORK OF THE INDONESIA NATIONAL SINGLE WINDOW

#### **Article 1**

- (1) The types of export and import licensing that can be served with the electronic system through INATRADE in the framework of the Indonesia National Single Window, are contained in Appendix I, which is an inseparable part of this Regulation of the Minister.
- (2) The types of export and import licensing that can only be served with the electronic system through INATRADE in the framework of the Indonesia National Single Window, are contained in Appendix II, which is an inseparable part of this Regulation of the Minister.

#### Article 2

The licensing service, as meant in Article 1 paragraph (2), can only be provided to the applicant who already has the Access Right as regulated in the Regulation of the Minister of Trade concerning the export and import licensing service with the electronic system through INATRADE in the framework of the Indonesia National Single Window.

#### Article 3

- (1) The service on the types of export and import licensing, as meant in Article 1, is carried out based on the Standard Operating Procedure and Service Level Arrangement.
- (2) The Standard Operating Procedure for the export and import licensing service, as meant in Article 1, is contained in Appendix III, which is an inseparable part of this Regulation of the Minister.
- (3) The Service Level Arrangement for the export and import licensing service, as meant in Article 1 paragraph (1), is contained in Appendix IV, which is an inseparable part of this Regulation of the Minister.

(4) The Service Level Arrangement for the export and import licensing service, as meant in Article 1 paragraph (2), is contained in Appendix V, which is an inseparable part of this Regulation of the Minister.

#### Article 4

At the time this Regulation of the Minister commences applicable, the Regulation of the Minister of Trade Number 40/M-DAG/PER/10/2010 concerning the Export and Import Licensing Types, Standard Operating Procedure and Service Level Arrangement with the Electronic System Through INATRADE in the Framework of the Indonesia National Single Window is withdrawn and declared not applicable.

#### Article 5

This Regulation of the Minister commences applicable on 24 June 2013.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
