**REGULATION OF THE MINISTER OF TRADE OF THE REPUBLIC OF
INDONESIA**

CONCERNING

**DETERMINATION OF EXPORT STANDARD PRICE FOR PROCESSED
MINING PRODUCTS THAT ARE IMPOSED EXPORT DUTY**

BY THE GRACE OF ALLAH THE ONE SUPREME GOD

THE MINISTER OF TRADE OF THE REPUBLIC OF INDONESIA,

- Considering :
- a. that in order to implement the provision of Article 2 paragraph (2) of the Regulation of the Minister of Trade Number 06/M-DAG/PER/1/2014 concerning Procedure to Determine the Export Standard Price for Processed Mining Products that are Imposed Export Duty, it is necessary to regulate the Export Standard Price for processed mining products that are imposed export duty;
 - b. that the determination of the Export Standard Price for processed mining products that are imposed export duty is carried out after taking account of the written proposal and result of the coordination meeting with the related technical agency;
 - c. that based on the considerations, as meant in letter a and letter b, it is necessary to determine the Regulation of the Minister of

Trade concerning Determination of the Export Standard Price for Processed Mining Products that are Imposed Export Duty;

HAS DECIDED:

To Stipulate : **THE REGULATION OF THE MINISTER OF TRADE CONCERNING THE DETERMINATION OF THE EXPORT STANDARD PRICE FOR PROCESSED MINING PRODUCTS THAT ARE IMPOSED EXPORT DUTY.**

Article 1

The determination of the Export Standard Price (HPE) is determined by following the highest average price at the international stock exchange, highest average Free On Board (FOB) price, highest average price that applies at the domestic market or highest average price at the processed mining products importing Country within the last month prior to the determination of HPE.

Article 2

The HPE for processed mining products is determined as contained in the Appendix, which is an inseparable part of this Regulation of the Minister.

Article 3

The HPE, as meant in Article 2, is used as basis for the determination of the Export Price to calculate the Export Duty by the Minister of Finances.

Article 4

The HPE, as meant in Article 2, applies from 1 January 2015 until 31 January 2015.

Article 5

In case the validity term of HPE has expired based on this Regulation of the Minister, and the new HPE is not determined yet, then the HPE as contained in this Regulation of the Minister is declared still applicable as the basis for calculation of the Export Duty until the new HPE is determined.

Article 6

At the time this Regulation of the Minister commences applicable, the Regulation of the Minister of Trade Number 87/M-DAG/PER/11/2014 concerning Determination of the Export Standard Price for Processed Mining Products that are Imposed Export Duty is withdrawn and declared not applicable.

Article 7

This Regulation of the Minister commences applicable on 1 January 2015.

So that it is known by everyone, the enactment of this Regulation of the Minister is instructed with its placement in the State Gazette of the Republic of Indonesia.
